

COVID-19 Financial Impact

Emergency Assistance for Entrepreneurs & Small Businesses

Paycheck Protection Program (PPP)

- Must have been operational on Feb 15th 2020 and had employees or independent contractors
- Section 1102 of the government initiated CARES Act temporarily permits the Small Business Administration (“SBA”) to guarantee 100% of 7(a) loans for Payroll, Mortgages payments and interest, Rent, and Utilities
- Up to 100% Loan Forgiveness (if at least 75% of funds were used for payroll costs); otherwise, loan has a maturity of 2 years @ 1% interest
- Business must NOT have over 500 employees (or meet specific SBA rules for those over 500 employees), or be a non-profit 501(c)(3)
- Min. \$1K, Max \$10M
- Debt incurred prior to Feb 2020
- Non-credit based funding
- Applicant cannot have any outstanding loans or Paycheck Protection Loans offered by the SBA, or be currently involved in a bankruptcy
- Last day to apply and receive loan funding is June 30, 2020, or until funds have been exhausted
- Apply through major bank lenders, but 100% SBA guaranteed (i.e, Bank of America)

WHO QUALIFIES?

- Independent Contractors, Entrepreneurs, and Small Business Owners with less than 500 employees (over 500 must meet additional SBA Guidelines)
- Anyone looking to recover up to 2.5 months of payroll and other business related fees
- No open Bankruptcies
- Applicant with 20% or more ownership in the business must not have any Criminal Charges within the last 5 years or pending cases
- Cannot be more than 60 days delinquent on child support obligations





Economic Injury Disaster Loan (EIDL) up to \$2,000,000 includes self-employed & independent contractors

- Must have been in business as of January 31st 2020
- Up to \$10K Advance, payable by direct deposit within 3 days of receipt of a completed application. These funds are considered a “grant” and do not have to be repaid under ANY circumstances.
- Business must NOT have over 500 employees (or meet specific SBA rules for those over 500 employees), or be a non-profit 501(c)(3)
- May be used to pay fixed debts, payroll, A/P, and other business-related expenses that cannot otherwise be paid due to the disaster’s impact
- Loan repayment at a 3.75% interest rate for small businesses, and 2.75% for non-profit organizations
- Up to a 30-year loan repayment option; however, terms are determined on a case-by-case basis contingent upon the borrower’s ability to repay the loan
- Last day to apply and receive loan funding is September 30, 2020, or until funds have been exhausted
- Apply Directly on SBA.gov

Weekly Unemployment Benefits

Attention all self-employed workers, gig workers (music artists, actors, actresses, etc.), 1099 independent contractors will now be qualified to apply for weekly unemployment benefits.

- Minimum of 50% of regular compensation/salary
- Plus an additional \$600 paid weekly in benefits

The United States Department of Labor signed this act on March 28, 2020. Your local Department of Labor office is expected to receive specific information on how to process your claims by April 10, 2020.

Stimulus Check

- Tax filers with adjusted gross income up to \$75,000 for individuals and up to \$150,000 for married couples filing joint returns will receive the full payment. For filers with income above those amounts, the payment amount is reduced by \$5 for each \$100 above the \$75,000/\$150,000 thresholds. Single filers with income exceeding \$99,000 and \$198,000 for joint filers with no children are not eligible. Social Security recipients and railroad retirees who are otherwise not required to file a tax return are also eligible and will not be required to file a return.
- Eligible taxpayers who filed tax returns for either 2019 or 2018 will automatically receive an economic impact payment of up to \$1,200 for individuals or \$2,400 for married couples and up to \$500 for each qualifying child.
- Persons with outstanding tax debt will still receive your stimulus
- Social Security recipients will receive their stimulus check in addition to their monthly SSI payment
- If you have not filed 2018 or 2019 and are not required, you may report your information to the IRS to receive your stimulus check

Purpose of this form:

This form is to be completed by the authorized representative of the Applicant and *submitted to your SBA Participating Lender*. Submission of the requested information is required to make a determination regarding eligibility for financial assistance. Failure to submit the information would affect that determination.

Instructions for completing this form:

With respect to “purpose of the loan,” payroll costs consist of compensation to employees (whose principal place of residence is the United States) in the form of salary, wages, commissions, or similar compensation; cash tips or the equivalent (based on employer records of past tips or, in the absence of such records, a reasonable, good-faith employer estimate of such tips); payment for vacation, parental, family, medical, or sick leave; allowance for separation or dismissal; payment for the provision of employee benefits consisting of group health care coverage, including insurance premiums, and retirement; payment of state and local taxes assessed on compensation of employees; and for an independent contractor or sole proprietor, wage, commissions, income, or net earnings from self-employment or similar compensation.

For purposes of calculating “Average Monthly Payroll,” most Applicants will use the average monthly payroll for 2019, excluding costs over \$100,000 on an annualized basis for each employee. For seasonal businesses, the Applicant may elect to instead use average monthly payroll for the time period between February 15, 2019 and June 30, 2019, excluding costs over \$100,000 on an annualized basis for each employee. For new businesses, average monthly payroll may be calculated using the time period from January 1, 2020 to February 29, 2020, excluding costs over \$100,000 on an annualized basis for each employee.

Privacy Act (5 U.S.C. 552a) – Under the provisions of the Privacy Act, you are not required to provide your social security number. Failure to provide your social security number may not affect any right, benefit or privilege to which you are entitled. (But see Debt Collection Notice regarding taxpayer identification number below.) Disclosures of name and other personal identifiers are required to provide SBA with sufficient information to make a character determination. When evaluating character, SBA considers the person’s integrity, candor, and disposition toward criminal actions. Additionally, SBA is specifically authorized to verify your criminal history, or lack thereof, pursuant to section 7(a)(1)(B), 15 USC Section 636(a)(1)(B) of the Small Business Act (the Act).

Disclosure of Information – Requests for information about another party may be denied unless SBA has the written permission of the individual to release the information to the requestor or unless the information is subject to disclosure under the Freedom of Information Act. The Privacy Act authorizes SBA to make certain “routine uses” of information protected by that Act. One such routine use is the disclosure of information maintained in SBA’s system of records when this information indicates a violation or potential violation of law, whether civil, criminal, or administrative in nature. Specifically, SBA may refer the information to the appropriate agency, whether Federal, State, local or foreign, charged with responsibility for, or otherwise involved in investigation, prosecution, enforcement or prevention of such violations. Another routine use is disclosure to other Federal agencies conducting background checks but only to the extent the information is relevant to the requesting agencies’ function. Debt Collection Act of 1982, Deficit Reduction Act of 1984 (31 U.S.C. 3701 et seq. and other titles) – SBA must obtain your taxpayer identification number when you apply for a loan. Right to Financial Privacy Act of 1978 (12 U.S.C. 3401) – The Right to Financial Privacy Act of 1978, grants SBA access rights to financial records held by financial institutions that are or have been doing business with you or your business including any financial

institutions participating in a loan or loan guaranty. SBA is only required provide a certificate of its compliance with the Act to a financial institution in connection with its first request for access to your financial records. SBA's access rights continue for the term of any approved loan guaranty agreement. SBA is also authorized to transfer to another Government authority any financial records concerning an approved loan or loan guarantee, as necessary to process, service or foreclose on a loan guaranty or collect on a defaulted loan guaranty.

Freedom of Information Act (5 U.S.C. 552) – Subject to certain exceptions, SBA must supply information reflected in agency files and records to a person requesting it. Information about approved loans that will be automatically released includes, among other things, statistics on our loan programs (individual borrowers are not identified in the statistics) and other information such as the names of the borrowers (and their officers, directors, stockholders or partners), the collateral pledged to secure the loan, the amount of the loan, its purpose in general terms and the maturity. Proprietary data on a borrower would not routinely be made available to third parties. All requests under this Act are to be addressed to the nearest SBA office and be identified as a Freedom of Information request.

Occupational Safety and Health Act (15 U.S.C. 651 et seq.) – The Occupational Safety and Health Administration (OSHA) can require businesses to modify facilities and procedures to protect employees. Businesses that do not comply may be fined, forced to cease operations, or prevented from starting operations. Signing this form is certification that the applicant, to the best of its knowledge, is in compliance with the applicable OSHA requirements, and will remain in compliance during the life of the loan.

Civil Rights (13 C.F.R. 112, 113, 117) – All businesses receiving SBA financial assistance must agree not to discriminate in any business practice, including employment practices and services to the public on the basis of categories cited in 13 C.F.R., Parts 112, 113, and 117 of SBA Regulations. All borrowers must display the "Equal Employment Opportunity Poster" prescribed by SBA.
